REPLY TO "MOTION TO MODIFY PRELIMINARY WRIT"

Come now Relators -- the Missouri Public Defender Commission, J. Marty Robinson, Director of the Missouri State Public Defender System, and Rod Hackathorn, District Defender – through counsel and reply to Respondents' "Motion To Modify Preliminary Writ" as follows:

1. On January 28, 2011, Respondents filed a "Motion To Modify Preliminary Writ." The motion requests that this Court's writ be modified so that Jared Blacksher may be allowed to enter a guilty plea, if he so chooses, and be sentenced.

2. Relators take no position on whether Mr. Blacksher should be allowed to plead guilty, *as long as* a guilty plea by him will not cause this Court to deem this writ case moot. Relators recognize that this Court has options available in whether and how to allow Mr. Blacksher to plead, and leave it to this Court to determine the appropriate course. However, if Mr. Blacksher is allowed to plead, Relators request and move that this Court not deem this writ action moot, and Relators believe that this writ action need not be rendered moot.

3. Relators believe this proceeding need not and should not be rendered moot because this proceeding falls within an exception to the mootness doctrine.

In *State ex rel. Missouri Public Defender Commission v. Pratte*, 298 S.W.3d 870, 885 n. 33 (Mo. banc 2009), the underlying criminal case in one of the writs this Court decided had been concluded. This Court, however, found that the writ case was not moot. “Even though an issue may appear to be moot, a court may decide the issue if ‘there is some legal principle at stake not previously ruled as to which a judicial declaration can and should be made for future guidance.’” *Id.* (quoting *State ex rel. City of Joplin v. Public Service Comm’n of State of Missouri*, 186 S.W.3d 290, 295 (Mo. App. W.D. 2005)). This Court held that the issue raised in *Pratte* was one which “[t]he trial courts, the state and the public defender have an interest in this Court determining....” *Pratte*, 298 S.W.3d at 885 n. 33.

4. The issue in the current case – whether the Public Defender may limit its availability to accept cases -- is of great interest and importance to every court in Missouri which hears criminal cases, as well as to the state, public defenders, and current and future persons charged with crimes throughout Missouri. The issue in this case will recur, since the Public Defender Office which covers the 38<sup>th</sup> and 31<sup>st</sup> Judicial Circuits remains on limited availability status, yet judges in those circuits continue to appoint the Public Defender's Office despite the Office's assertion that it is not available to accept cases. Attached to this reply motion is a list of cases from the 38<sup>th</sup> and 31<sup>st</sup> Judicial Circuits in which the Public Defender has been ordered to provide representation, despite informing the courts that it was unavailable (Exhibit A). Furthermore, the Public Defender Director has to date placed seven other Public Defender Offices covering 20 counties throughout Missouri on limited availability status, and courts in those jurisdictions continue to appoint the Public Defender even though those Offices have informed the courts that they are unavailable. Trial courts, prosecutors and public defenders throughout Missouri need and are awaiting this Court's guidance on this issue.

5. Moreover, this Court previously appointed a special master to take additional evidence in this case and decide certain questions. The master conducted an extensive all-day evidentiary hearing in this case on November 12, 2010, at which both parties in this action presented numerous witnesses and

substantial documentary exhibits. It would be a waste of judicial and state resources for the parties to have to begin this process anew in another underlying criminal case, where the issues to be determined will be identical to those here. Judicial economy dictates that this current writ action not be deemed moot, if Mr. Blacksher is allowed to plead guilty. *Cf. State ex rel. Noranda Aluminum Inc. v. Raines*, 706 S.W.2d 861, 862 (Mo. banc 1986)(“[W]here there is an issue which might otherwise escape this Court's attention for some time and which in the meantime is being decided by administrative bodies or trial courts ... and, the issue is being decided wrongly and is not a mere misapplication of law; and, where the aggrieved party may suffer considerable hardship and expense as a consequence of such action, we may entertain the writ for purposes of judicial economy under our authority to issue and determine original remedial writs.” (citation and internal quotation marks omitted)).

6. Therefore, Relators take no position on whether Mr. Blacksher should be allowed to plead guilty, *as long as* such option will not render this current writ action moot. Relators suggest possible options might include allowing Mr. Blacksher to plead guilty and yet not deem the case moot under the exception to the mootness doctrine used in *Pratte*, 298 S.W.3d at 885 n. 33, and/or substituting as additional underlying cases the list of cases attached to this reply motion.

7. However, if this Court believes that this writ action would be rendered moot if Mr. Blacksher would be allowed to plead guilty, then Relators object to any modification of the preliminary writ. In addition to the financial cost and additional attorney time that would be required to commence new litigation raising the identical issue as here, the Relators' current and future clients will be irreparably harmed if the District 31 Public Defender Office must continue to operate under conditions of excessive caseload while new, prolonged litigation begins anew and proceeds. Relators respectfully request that this Court decide the issue here in the current case.

8. Morris Mettler, the Assistant Public Defender who was representing Mr. Blacksher prior to this Court issuing its preliminary writ, spoke with Mr. Blacksher on January 31, 2011, and Mr. Blacksher indicates he would like to proceed with a guilty plea. Relators are willing to direct Mr. Mettler to represent Mr. Blacksher at a guilty plea *as long as* such representation will not be deemed by this Court to render this writ action moot.

WHEREFORE, Relators take no position on whether Mr. Blacksher should be allowed to plead guilty, *as long as* this Court will not deem this current writ action moot.


