**PROBABLE CAUSE STATEMENT
FELONY**

Date: December 2, 2010

I, Detective Wendell Helton a law enforcement officer, knowing that false statements made herein are punishable by law, state that I have probable cause to believe that, Paul Ray Rose DOB: 05-17-1966, [REDACTED], committed one or more of the following criminal offenses on between the months of June to September 2010 while at 224 Beryl Road Spokane, Christian County Missouri 65754:

566.067-Child Molestation first degree

Those facts supporting this belief which are true based upon the following information gained by my investigation are as follows:

Paul Rose allegedly committed the crime of Child Molestation between the months of June to September 2010 while at 224 Beryl Road Spokane, Christian County Missouri 65754 by putting his finger inside twelve year old D. W.'s vagina.

During a forensic interview conducted at the Child Advocacy Center D.W. made the following statements. She said she was playing on the Bonsai waterslide with her brothers when her mom and Paul came out to play with them at 224 Beryl Road in Spokane. She said she was on the slide this summer. She said her mom was spraying her brothers with a hose and Paul was acting like he was giving her a "wedgies" but he was touching her inappropriately. On an anatomically correct drawing she identified the female vagina as the genital area. She said Paul "fingered" her. D.W. said his finger was touching the outside of her genital area under her bathing suit. She said one time her mom told her Paul wanted to play with her but she told her mom she didn't want to, but would not tell her why because she was scared. [REDACTED] said she went upstairs and he supposedly gave her a "wedgie" but he stuck his finger in her.

On 11/08/2010 Paul Rose came to the Christian County Sheriff's Office for an interview. Post Miranda he made the following statement. He never touched D.W.'s vagina.

On 11/11/2010 Amanda Williams, D.W.'s mother came to the Christian County Sheriff's Office to talk with me. She told me she does not believe D.W.
